Privacy Policy Statement

This Privacy Policy describes how Ra-Lin & Associates, Inc. ("RaLin," " we ," " our ," or " us ") collects, uses, and shares information about you and applies to your use of any online service that posts a link to this Privacy Policy, including our website located at <u>www.ralinconstruction.com</u> and all features, content, and other services that we own, control, and make available through such online service (collectively, the " Service "). What Information Do We Collect and Store?

Except as disclosed below, we don't sell, trade, give away, or rent your personal information to any third party outside of RaLin. We try to limit the information we collect from and share about you.

Personal Information

We collect and store personal information that you provide to us, including through the Website, at our facilities, and in communications with our staff. We combine the information we receive from or about you through any of these channels and use and disclose it in accordance with this Statement.

You can use and visit our website without submitting any personal information; however, in order to utilize and access specific features, you may be asked to submit your personal information. Personal information means information that may be used to readily identify, contact, or locate an individual and may include, but is not limited to, your full name, company name, birth date, email, physical address, telephone number, and gender.
